Discussion on 2024 Report Recommendations

The full committee deliberated on recommendations for the 2024 report, voted on recommendations to be included in the report, and prepared for their respective subcommittee working sessions to refine language for the final selection of recommendations based on input.

The committee voted to include recommendations for VA to address the following issues:

- Women Veterans Call Center:
 - Providing additional resources to enhance advertising for the call center to increase awareness of VA's services.
- Homeless Women Veterans/Medical Billing Challenges;
 - Examining the correlation between medical billing challenges and homelessness in women Veterans.
- Reproductive Health:

- Capturing utilization of in vitro fertilization to identify ways to better serve women Veterans.
- Women Veterans Journey Map:
 - Disseminating the Women Veterans Journey Map to promote better awareness of women Veterans' barriers to accessing VA's benefits and services, and promote more utilization.
- Women Veterans Only Military Sexual Trauma (MST) Facility:
 - o Establishment of a women's only facility to address MST.
- Tailored Communications to Women Veterans:
 - Routine VISN-specific dissemination of information to women Veterans regarding outreach, local resources, programs and events focused on women's health.
- Feasibility Study for the Center for Women Veterans (CWV):
 - Examination of CWV's resources to ensure that CWV can efficiently carry out the statutory, regulatory, and implied duties and functions in a timely manner.
